In order for a greater number of children to experience Happy Time Camp, we are allowing some of the campers to stay on private lots located on the Brown City Camp Grounds.

GUIDELINES FOR LOT STAYS

- ◆ Fees will be the same for campers staying on lots as they are for campers staying in dorms.
- ◆ Deadlines for registration for "Lot Campers" are the same as the deadlines for "Dorm Campers."
- ◆ All campers will follow the camp schedule.
- ◆ All campers will eat together in the cafeteria.
- ◆ All campers will be assigned a counselor. The counselors to the "Lot Campers" will have the same responsibilities as the counselors to the "Dorm Campers. This includes having evening devotions with their campers.
- ◆ Lot Campers will be expected to participate in room cleanup activities at their lot site. The adult staying with the campers is asked to have the campers be responsible for keeping their living area in a neat manner. Their living areas will be inspected daily, just like the dorms are inspected daily!
- ◆ Lot campers will be provided a place in the old goodie shack, by the youth office, for storing their daily belongings. I.e. swim suit, towel, Bible, etc.
- ◆ Lot Campers are not to go to their lot sites unless they have permission from the proper HTC staff.
- ◆ There are to be no more than six campers staying on the same lot.
- ◆ **It is the responsibility of the parents of the lot campers to arrange for the adult that will stay with the children.**
